By signing this registration form, I agree and/or acknowledge the following:

- §1 The ÖVV (Österreichischer Volleyballverband) is the sole organiser of the Austrian Snow Volleyball National Championship.
- §2 I am well-experienced in playing Volleyball in some of its forms and I am familiar with the relevant technique.
- §3 The ÖVV appointed a local organiser Chaka² GmbH (Organiser) to conduct the present Snow Volleyball event. I agree to abide by the instructions of the ÖVV and Organiser concerning the organisation of the ÖVV Snow Volleyball event. In particular, the instructions concerning **Covid-19 related measures (see attachment 1)**, advertisement and sponsorship.
- §4 I carefully read, understood and agreed to abide by the 2018 CEV/FIVB Snow Volleyball Rules; available in the Snow Volleyball section on the CEV website. In particular, the chapters concerning the player's equipment and conduct. The equipment I use complies with the above mentioned rules and is under my exclusive responsibility.
- §5 I am eligible to participate to a ÖVV competition when the following requirements are fulfilled:
 - a. The present registration form is signed,
 - b. ÖVV, which is a CEV member, registered me,
 - c. The registration fee is paid.
- §6 I am aware of the risks of playing Snow Volleyball; especially that there is a risk of injury in the Snow Volleyball event. Playing volleyball on natural snow and ice bears the risk of dangerous falls and therefore the risk of physical injury; particularly with regard to the fact that natural ice is not flat, but bumpy, and the condition is dependent on temperature and weather; e.g. cracks or holes might appear in the snow and ice. Furthermore, there might be snowy or icy spots on the Snow Volleyball courts which make the unevenness invisible. Also the use of the Snow Volleyball courts bears the risk of crashing into safety nets, billboards, inflatable side walls or net pillars. I accept these risks and agree to adapt my practice of Volleyball or Beach Volleyball.
- §7 I carefully read, understood and agreed to the scope of the insurance policy subscribed by the ÖVV; available here: <u>http://ebook.cev.lu/beach/imssa/IMSSA_cover_for_Athletes.pdf</u>
- §8 I shall not, directly or indirectly, by any means and in any form, suggest or refer to a legal entity, its products, goods, services or brands or use content which are likely prejudicial to individual's health and safety and/or harm any person due to its sex, colour, language, religion, political or other opinion, national or social origin, association with a national minority, property, birth or other status. I shall behave and act in a way respectful of the above mentioned.
- §9 I shall avoid, imped and stop any suggestion or given impression that a third party is associated or connected, by any means and in any form, to the ÖVV or the ÖVV Snow Volleyball event. I shall refrain from being involved or contributing, directly or indirectly, actively or not, to such third party association.
- §10 I shall use the equipment provided by the ÖVV or the Organiser, at any time during the ÖVV Snow Volleyball event.
- §11 I shall indemnify the ÖVV or Organiser and hold it harmless with respect to all liabilities, damages, costs and expenses suffered or incurred by the ÖVV or Organiser as a result of a breach of any of my

obligations, conduct mentioned in the Official Snow Volleyball Rules or in the present player's commitment.

- §12 I freely consent to the processing of my personal data, concerning the Snow Volleyball practice, by the ÖVV and the Organiser, for the purposes of the competition organisation and promotion of Snow Volleyball; which may be transfered to non EU States members and access by natural and legal persons participating or interesting in the ÖVV Snow Volleyball event. I am aware of my right to access, rectify or object such processing.
- §13 I grant the ÖVV the non-exclusive right to use, exploit and sub-license to the ÖVV commercial partners and the Organiser, in the ÖVV members' territories and on a free basis, my name, nickname, family name, voice and image (identification markers). This right is granted from the registration date, for the ÖVV Snow Volleyball event organisation and promotion, commercial activities, Snow Volleyball promotion and history purposes. This right is related to the sport of Snow Volleyball. It may combine several players' identification markers and associate them with a ÖVV commercial partner's good, service, product or brand without implying any endorsement of the latter by myself; unless agreed.
- §14 The Law of Austria is the governing law.
- §15 The ÖVV is competent in case of a dispute with the ÖVV or the Organiser, arising from the sport aspect of the ÖVV Snow Volleyball event. The dispute shall be settled according to the ÖVV regulations.
- §16 The data provided in this registration form are true and accurate to the best of my knowledge.

Attachment 1: Covid 19 Measures - Snow Volleyball Events

The team captain has to show negative test results of a Covid-19 test from all team members. (PCR Test not older than 72h or antigen quick test not older than 48h).

All athletes have to perform an antigen quick test when arriving at Hotel Oberwimm on Friday 5th of March 2021 between 17.00 and 19.00 o`clock.

Teams have to nominate one team member to participate at the technical meeting on Friday 5th of March 2021 19.00 0`clock.

At the event mentioned above, the health of everyone involved has top priority, which is why appropriate safety measures are taken during the stay. We would like to advise you to read the security guidelines with regard to COVID-19 carefully and to adhere to them during your stay in Wagrain.

Refrain from attending the event if you feel sick in any way. If you come to Wagrain with symptoms of illness, we cannot allow participation in the event in order to protect everyone involved. You should stay away from the event if you have had contact with confirmed COVID-19 cases or people with suspected COVID-19.

In the event of one of the two situations listed above, we ask you to contact the Chaka2 COVID-19 event hotline (24/7): +43 664 1412224

During the stay in Wagrain, a safety distance of at least 2,0 m from other people must be maintained.

Please disinfect your hands regularly on site. We will be happy to provide you with an appropriate hand disinfectant.

Mouth and nose protection (professional hygiene masks – FFP2) must always be worn. This applies in particular to the stay in Hotel Oberwimm or the competition venue. Please make sure to bring your own FFP2 mask.

At breakfast, lunch or dinner (in the hotels or the competition venue) please ensure that there is a sufficient safety distance of 2m between people. Please wear mouth and nose protection until you have reached your seat.

In principle, contact with other people who do not take part or are not involved in the event should be completely restricted during the stay in Wagrain.

No gatherings and crowdings are allowed at the competition venue as well as the athletes hotel. Follow social distancing principles during competition as well as during recovery time in the hotel.

All persons directly involved in the event receive instruction from a trained COVID-19 officer on arrival.

We would also like to point out that we have no way of avoiding infection beyond the measures mentioned. You therefore take part in the event at your own risk.

Chaka2 GmbH is entitled at any time, even after the start of the event, to request information in connection with a COVID- 19 disease and / or suspicion, in particular examination evidence, a current COVID-19 test, which shows that none. There is an infection and / or to request movement logs from which it can be seen that I am not sick or infected with COVID-19 and / or that he has not had any contact with anyone infected with COVID-19.

You grant Chaka2 GmbH the right to receive the test results from your person in Salzburg by email or text message and that this is in your interest in terms of data protection law.

You undertake to follow the instructions of Chaka2 GmbH with regard to measures regarding COVID-19 in any case, to take other precautionary measures regarding COVID-19 (requirements regarding keeping a safe distance, mask requirement etc.) over you during the event.
